### **NOTICE INVITING QUOTATION**

Sealed quotations are invited for the Appointment of Technical Consultant for Forest Clearance under FRA Act for the transfer of 0.8775 hectare (10-16-19 Bigha) of Forest Land for the construction of State Allied Health Institute (Paramedical) at Nerchowk.

The quotations should be sent to "The Additional Director(Admn.), SLBSGMCH Mandi at Nerchowk, Distt. Mandi, HP" on or before 2.2.2024 up to 11:00 AM and same will be opened on the same day at 11:30 PM in the presence of the worthy Principal, undersigned and Section Officer (F&A) of this Medical College as well as Bidders or their authorized representatives who may like to be present at the time.

#### **SCOPE OF WORK**

To prepare & submit the forest diversion application as per "Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006" and scope of work encompasses up to obtaining Forest Clearance from Forest Department by submitting necessary documentation including DGPS survey map of Forest plots, Compensatory Afforestation site or any other required survey map to the concerned authorities.

To arrange Forest Enumeration, Compensatory Afforestation program, Forest Right Act Certificate, arranging field verification and compliance, Pillar Posting on the forest demarcated boundary in consultation with forest officials, obtaining local clearances, if any, expediting & follow-up with Forest Department and furnish clarifications, additional documentation, presentation to DFO, provide all technical and logistic support to Forest Department etc. in obtaining forest clearance.

The Consultant will have to undertake all necessary studies as may be required as per the notification(s) issued by the MoEF&CC during the execution of the assignment.

#### Eligibility criteria

- The Consulting Organization should have undertaken (completed) at least one (1) Consultancy assignment for forest related activities like Preparation of Forest Clearance application, Tree Enumeration, obtaining FRA certificate, Compensatory Afforestation etc. under FC Act, 1980 & FRA Act, 2006 in last five (5) years from the bid due date. The Consulting Organisation should submit copy of Letter of Award (LoA) or equivalent or any other documentary evidence on the above.
- ii) The Consulting Organization should be submitting the quotations on its own and not in consortium with any other Consulting Organization.

#### Period of Engagement

The minimum time period for the completion of work would be within the time limit of 2 months and maximum upto 6 months.
