1. Should have PTZ Camera / Speed Dome Camera.
2. Should have IP Camera.
3. Should have Camera Image Sensing capacity 2MP (1920 x 1080 Pixel) or better.
4. Should have Maximum Frame Rates (frames per second) Supported 25/30.
5. Should have Quad Number of simultaneous video.
6. Should have Full/Compressed Streams.
7. Should have IR illumination Range(meter): 15-30.
8. The Installation Type/ Area of use should be Indoor.
9. Should have fixed Lens.
10. The Focal Length for Fixed / Fisheye Lens Type (mm) should be 2.8 or better.
11. The Type of network required to transmit video / Image recorded by camera should be Wired.
12. Should have On Board SD Card Support.
13. The SD Card Capacity should be 512 GB or more.
14. Should have Comprehensive Warranty of 2 years.
15. The Availability of security testing report for CCTV/VSS issued by standardization Testing and Quality certification (STQC) Laboratory or any other agency should be notified by Meity.
16. Should be Complying to the requirement of clause 5 of S.O. 1119 (E) on the subject: Public Procurement (Preference to make in India) Order 2017-Notifying CCTV/Video Surveillance System for Security in furtherance of the order at dated 6th March, 2024.
17. Should have BIS Registration (CRS) for safety general requirements as per IS 13252 (Part 1).
18. The supplier should agree to provide all relevant documents test report/supporting document/reports etc. to the college authority at the time of bidding or on demand.
19. Total number of cameras required is 24 (detailed location of cameras to be installed is attached with this letter).
20. Along with Cameras a LED Monitor with 65 inches of display and Storage for look time for continuous 1-week time.

TERMS AND CONDITIONS

1. The Limited Tender should be clearly superscribed as **"Limited Tender for CCTV Cameras for the Auditorium Hall of SLBSGMCH, Mandi at Nerchowk."** The quoted rates, along with applicable GST, must be clearly mentioned.
2. The tender document and other instructions can be downloaded or viewed from the website <https://www.slbsgmchmandi.com> and tender fee @ Rs 500/-(Five Hundred only) (non-refundable) as mentioned in the tender form shall have to be deposited in the shape of demand draft favoring of the Additional Director (Admn.) SLBSGMCH Mandi at Nerchowk, District Mandi, HP before the last date and time of submission of tender.
3. The Limited Tender must be accompanied with an Earnest Money for Rs. 10,000/- (Rs. Ten Thousand Only) in the shape of FDR duly pledged in favor of the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) without which tender will be rejected.
4. 100 % quantity of material should be supplied & installed within 15 days.
5. Penalty will be imposed as deemed fit by the undersigned for delay supply and the penalty for late supply will be deducted for the bill of the successful tenderer if he failed to supply the item as per time schedule given Supply Order, However, the penalty can be either waived off or reduced solely at the discretion of the undersigned, if a cogent reason is shown by the tenderer in advance, only for a reasonable period.
6. The Tenderer is required to submit the Bid in a sealed cover along with Tender Form, acceptance of terms & conditions of the tender, undertaking/declaration, attested copies of

documents (Valid registration certificate issued by competent authority, TIN No./ PAN/GST No., Aadhar Card/address proof, copy of Partnership Deed in case of Partnership firms mentioned in the terms and conditions. Earnest Money in the shape of FDR duly pledged in favor of the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P.) shall also be placed in this envelop.

7. Limited Tender should be sent through registered post/ speed post/courier /By Hand only to the "Additional Director, Shri Lal Bahadur Shastri Govt. Medical College and Hospital Mandi at Nerchowk, PO Bhangrotu, Tehsil Balh, Distt. Mandi H.P. 175021" **In the main envelope separate envelope shall be used for Financial Bid and on the front of the envelope "Financial Bid" shall be clearly mentioned.**
8. Conditional tenders will not be entertained.
9. Supplies not conforming to the approved sample will be rejected and returned to the firm at their risk and costs.
10. Company/Partnership firm should not be blacklisted by any state or central Government or any Govt. entity in the last two years. A self-declaration on letter head of the company/firm should be attached. **(Annexure-A)**
11. In case the successful tenderers after having received the supply order from the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) fails to execute the job, the Additional Director will be at liberty to entrust job to other firm/Company at the risk and cost of such failed tenderer. Such failed tenderers will be liable to pay such damages as may claimed by the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P). Such default tenderer shall also be liable to be blacklisted and his security money be forfeited.
12. The Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) reserves the right to accept or reject any tender without assigning any reasons whatsoever.
13. In case of any dispute or difference rising out of regarding the interpretation of any clause of these Terms & Conditions the matter shall be referred for arbitration to the H.P. Govt. whose decision shall be final and binding on both the parties.
14. These terms and Conditions will be treated as an agreement between the undersigned and the successful tenderer/contractor of this tender.
15. The power to increase and decrease the number Equipments is reserved with the Additional Director, SLBSGMCH, Mandi at Nerchowk.

16. The last date of receipt of limited tenders **10.09.2025 up to 11:00 AM** and the same will be opened on the same day at **03:00 PM** in the presence of in the presence of the **Technical Committee Members** for the purchase of CCTV Cameras as well as tenderers or their authorized representatives who may like to be present at the time.
17. All disputes shall be settled within at Himachal Pradesh High Court, Shimla only.
18. Payment shall be released only after successful completion of the entire work and subsequent approval by the Technical Committee of this institution.
19. The successful bidders have to furnish the **Performance Security Deposit @ Rs.50,000/- (Rupees Fifty Thousand Only)** of contract value in the form of FD/BG/TD/CD for **Six months extra of the contract period** from any Nationalized/Schedule bank duly pledged in favour of Additional Director SLBS Govt. Medical College Mandi at Nerchowk & payable at Nerchowk only. The EMD deposited by successful bidder may be adjusted towards Security Deposit as demanded above after its validation for the required period.
