"NOTICE INVITING LIMITED TENDER"

Sealed limited tenders are hereby invited from authorized agencies/firms for the supply of **Chemicals and Reagents for the Department of Anatomy, SLBSGMCH, Mandi at Nerchowk**. The last date for submission of quotations is **06.10.2025 up to 11:00 AM**. Quotations received after the stipulated time will not be entertained. The tenders will be opened on the same day at **03:00 PM** in the presence of the Technical Committee of the Department of Anatomy at SLBSGMCH, Mandi at Nerchowk. The detailed specifications of the required Chemicals and Reagents, along with the Terms & Conditions, are provided below:-

TERMS AND CONDITIONS

1. The limited tender must be superscripted as “**Chemicals and Reagents in Department of Anatomy**” SLBSGMCH Mandi at Nerchowk. The Rates and GST (as applicable) should be clear.
2. The tender document and detailed instructions can be viewed or downloaded from the website <https://www.slbsgmchmandi.com>. A non-refundable **tender fee of ₹500/- (Rupees Five Hundred only)**, as specified in the tender form, must be deposited in the form of a Demand Draft drawn in favour of the Additional Director (Admn.), SLBSGMCH, Mandi at Nerchowk, District Mandi, HP, prior to the last date and time for submission of the tender.
3. The Limited Tender must be accompanied with an **Earnest Money for Rs. 20,000/- (Rs. Twenty Thousand Only)** in the shape of FDR duly pledged in favor of the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) without which tender will be rejected.
4. 100 % quantity of material should be supplied & installed within 15 days.
5. Penalty will be imposed as deemed fit by the undersigned for delay supply and the penalty for late supply will be deducted for the bill of the successful tenderer if he fails to supply the item as per time schedule given Supply Order, However, the penalty can be either waived off or reduced solely at the discretion of the undersigned, if a cogent reason is shown by the tenderer in advance, only for a reasonable period.
6. The Tenderer is required to submit the Bid in a sealed cover along with **Tender Form, acceptance of terms & conditions of the tender, undertaking/declaration, attested copies of documents (Valid registration certificate issued by competent authority, TIN No. / PAN/GST No., Aadhar Card/address proof, copy of Partnership Deed** in case of Partnership firms mentioned in the terms and conditions. Earnest Money in the shape of FDR duly pledged in favor of the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) shall also be placed in this envelop.
7. **OEM Authorization certificate** should be provided.
8. Limited Tender should be sent through registered post/ speed post/courier /By Hand only to the “Additional Director, Shri Lal Bahadur Shastri Govt. Medical College and Hospital Mandi at Nerchowk, PO Bhangrotu, Tehsil Balh, Distt. Mandi H.P. 175021” **in the main envelope**

separate envelope shall be used for Financial Bid and on the front of the envelope "Financial Bid" shall be clearly mentioned.

9. Conditional tenders will not be entertained.
10. The quoted rates shall remain valid for **two years** from the date of the contract or supply order and may be extended further at the discretion of the authority.
11. Supplies not conforming to the approved sample will be rejected and returned to the firm at their risk and costs.
12. Company/Partnership firm should not be blacklisted by any state or central Government or any Govt. entity in the last two years. **(Annexure-A)**
13. In case the successful tenderer after having received the supply order from the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) fails to execute the job, the Additional Director will be at liberty to entrust job to other firm/Company at the risk and cost of such failed tenderer. Such failed tenderer will be liable to pay such damages as may be claimed by the Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P). Such default tenderer shall also be liable to be blacklisted and his security money be forfeited.
14. The Additional Director, SLBS Govt. Medical College Mandi at Nerchowk (H.P) reserves the right to accept or reject any tender without assigning any reasons whatsoever.
15. In case of any dispute or difference rising out of regarding the interpretation of any clause of these Terms & Conditions the matter shall be referred for arbitration to the H.P. Govt. whose decision shall be final and binding on both the parties.
16. These terms and Conditions will be treated as an agreement between the undersigned and the successful tenderer/contractor of this tender.
17. The power to increase and decrease the number of Equipment is reserved with the Additional Director, SLBSGMCH, Mandi at Nerchowk.
18. The last date of receipt of sealed limited tender is **06.10.2025 up to 11:00 A.M.** and the same will be opened on the same day at **03:00 P.M.** in the presence of Technical Committee of Department of Anatomy of this Medical College as well as tenderers or their authorized representatives who may like to be present at the time.

19. All disputes shall be settled within at Himachal Pradesh High Court, Shimla only.

20. The successful bidder shall be required to furnish a **Performance Security Deposit of ₹25,000/- (Rupees Twenty-Five Thousand only)** or as applicable, in the form of FD/BG/TD/CD, valid for six months beyond the contract period, from any Nationalized/Scheduled Bank. The instrument shall be duly pledged in favour of the Additional Director, SLBS Government Medical College, Mandi at Nerchowk, and payable at Nerchowk only. The Earnest Money Deposit (EMD) submitted by the successful bidder may be adjusted towards the required Performance Security Deposit after its validation for the stipulated period. If the successful bidder fails to furnish the full Performance Security Deposit or the differential amount between the Security Deposit and the EMD within **Twenty-One (21) days** of the issue of the **Supply Order**, the EMD shall be forfeited and the award of the tender shall stand automatically cancelled at the bidder's cost and liability, unless a time extension has been specifically granted by SLBS Government Medical College, Mandi at Nerchowk.
