"LIMITED TENDER NOTICE"

Sealed limited tenders are hereby invited from **registered agencies/firms** by the undersigned for the **Repair and Restoration of Non-Functional/Partially Functional Autoclave Machines** installed in **CSSD and TSSU, SLBS Government Medical College, Mandi at Nerchowk (H.P.)**.

The bidders are required to **physically inspect the machines at the site on any working day** before quoting their rates. The rates quoted shall be deemed to have been submitted after due inspection and assessment of the condition of the machines.

The **last date and time for submission of sealed tenders is 25/09/2026 up to 11:00 AM**. No tender shall be accepted after the stipulated date and time under any circumstances. The sealed tenders shall be **opened on the same day, i.e. 25/09/2026 at 03:00 PM**, by the Tender Opening Committee in the presence of the participating bidders or their duly authorized representatives who may wish to attend the tender opening.

Terms and Conditions:

- The Tenderer is required to submit the Bid in a sealed cover & addressed to the undersigned and the envelop should be marked **"Repair and Restoration of Non-Functional/Partially Functional following Autoclave Machine of CSSD and TSSU, SLBSGMCH Mandi at Nerchowk due on 25.09.2026 at 3.00pm.**
- Sealed tender should accompany the following documents failing which the tender will be summarily rejected.
 - Earnest Money for Rs. 5,000/- (Five Thousand) refundable only in the shape of FDR duly pledged in favor of Member Secretary cum-Sr. Medical Superintendent (RKS), SLBS Govt. Medical College Mandi at Nerchowk (H.P). The Earnest money shall be refunded to the unsuccessful bidder after completion of tender process.
 - Attested copies of documents (Valid registration certificate issued by competent authority, TIN No./ PAN/GST No.)
 - Aadhaar Card/address proof
 - Copy of Partnership Deed in case of Partnership firms mentioned in the terms and conditions.
 - OEM authorization Certificate (If applicable)
 - A copy of at least one Work Completion Certificate and/or Work Order relating to the repair and maintenance of medical equipment during the last three years must be enclosed with the bid.
- The repair work should be carried out within a period of **15 days** after receiving Repair work order.



4. Only registered agencies/firms having proven experience in repair and maintenance of medical equipment shall be eligible to participate in the tender process.
5. The rates quoted shall be inclusive of all taxes, duties, transportation, labour charges, and any other incidental expenses.
6. The Rates should be valid for **one year** from the date of opening of Limited Tender.
7. Payment shall be released only after satisfactory completion of the repair work and submission of the required documents/bills certification by the concerned department. No advance payment will be made.

9. Penalty will be imposed as deemed fit by the undersigned for delay in repair work and the penalty will be deducted for the bill of the successful Bidder if he failed to repair the above item as per time schedule given in the Supply Order, However, the penalty can be either waived off or reduced solely at the discretion of the undersigned, if a cogent reason is shown by the bidder in advance, only for a reasonable period.
10. Conditional bids shall not be entertained and are liable to be rejected.
11. In the event that the successful bidder, after receipt of the repair order from the **Member Secretary-cum-SMS (RKS), SLBS Government Medical College, Mandi at Nerchowk (H.P.)**, fails to execute the assigned job within the stipulated period, the **Member Secretary-cum-SMS (RKS)** shall be at liberty to get the job executed through any other firm/company at the **risk and cost of the defaulting bidder**. The defaulting bidder shall be liable to bear all additional costs, losses, damages, or other expenses incurred by the **Member Secretary-cum-Sr. Medical Superintendent (RKS), SLBS Government Medical College, Mandi at Nerchowk (H.P.)**, in consequence of such failure.
12. The Member Secretary cum-SMS (RKS), SLBS Govt. Medical College Mandi at Nerchowk (H.P) reserves the right to accept or reject any bidder without assigning any reasons whatsoever.
13. These terms and Conditions shall be treated as an agreement between the undersigned and the successful bidder/contractor.
14. The bidder shall provide a minimum warranty of 6 months on all repaired/replaced parts from the date of successful commissioning.
15. GST shall be applicable as per Govt. norms and must be shown separately in the financial bid.
16. All disputes arising out of this Limited Tender shall be subject to the exclusive jurisdiction of the competent courts in Himachal Pradesh.
